NEW ENERGY BUSINESS SEGMENT

According to the Company's preliminary statistics, the power generation of the Group on a consolidated basis for the 2023 fourth quarter amounted to 4,081,455.41 MWh, representing a decrease of 1.84% over the corresponding period of 2022; the on-grid power generation amounted to 3,989,812.55 MWh, representing a decrease of 1.97% over the corresponding period of 2022. As of 31 December 2023, the accumulated power generation amounted to 14,254,047.49 MWh, representing an increase of 0.39% over the corresponding period of 2022; the accumulated on-grid power generation amounted to 13,929,926.32 MWh, representing an increase of 0.43% over the corresponding period of 2022.
