## **OPERATING DATA OF 2023 SECOND QUARTER**

The board of directors (the "**Board**") of China Suntien Green Energy Corporation Limited (the "**Company**") hereby announces the key operating data of 2023 second quarter of the Company and its subsidiaries (collectively, the "**Group**").

## **NEW ENERGY BUSINESS SEGMENT**

According to the Company's preliminary statistics, the power generation of the Group on a consolidated basis for the 2023 second quarter amounted to 3,706,851.15 MWh, representing an increase of 0.21% over the corresponding period of 2022. As of 30 June 2023, the accumulated power generation amounted to 7,813,180.15 MWh, representing an increase of 1.99% over the corresponding period of 2022; the accumulated on-grid power generation amounted to 7,640,240.16 MWh, representing an increase of 2.09% over the corresponding period of 2022; from January to June 2023, the average on-grid tariff (tax exclusive) of the group was RMB0.44/KWh, representing a decrease of 2.22% over the corresponding period of 2022; the Group's market-based transacted electricity volume amounted to 2,851,645.86 MWh, while the proportion of transacted electricity volume amounted to 37.32%, representing an increase of 16.72 percentage points over the corresponding period of 2022.

As of 30 June 2023, the accumulated transmission volume of gas amounted to 2,385.1368 million cubic meters, representing a decrease of 2.87% over the corresponding period of 2022, of which sales volume of gas amounted to 2,059.4560 million cubic meters, representing a decrease of 5.84% over the corresponding period of 2022, while the transmission volume for clients amounted to 325.6808 million cubic meters, representing an increase of 21.28% over the corresponding period of 2022.
